It is one of the key initiatives to identify, assess and recognise the organisations operating in India, which are creating a measurable socio-economic value by identifying and addressing social and environmental problems that intersect with their businesses.

Creating Shared Value Concept

Creating Shared Value (CSV) is a framework for creating economic value while simultaneously addressing societal needs and challenges. It is uplifting the underserved sections of the society through a business model at a profit.

CSV = Social Value + Economic Value Creating Shared Value is addressing societal needs and challenges with a business model. The concept was defined in the Harvard Business Review article 'Creating Shared Value', by Professor Michael E. Porter and Mark R. Kramer.
